SEARCH WARRANT

THE PEOPLE OF THE STATE OF CALIFORNIA

The affidavit filed herewith by _____, sworn to and subscribed before me on this date, has established probable cause for this warrant which you are ordered to execute as follows:

Sealing Order: The following documents shall be sealed and delivered into the custody of the Clerk of the Court pending further court order: All documents filed herewith. Grounds for sealing: Informant protection (Evidence Code § 1041) Official information (Evidence Code § 1040) Pursuant to Rule 2.550 of the California Rules of Court, the document(s) identified above shall be sealed and retained in the following manner pending further order of the court: (1) The document(s) shall be sealed in an envelope with a copy of this Order affixed to the front of the envelope; and (2) The Clerk of the Court shall retain custody of the envelope in a secure place and shall not permit it to be opened by anyone except as authorized by written order of the Court.

Nondisclosure Order: Pending further order of this court, the officers, employees, and agents of the entity served with this warrant are hereby ordered not to disclose information to any person that would reveal, or tend to reveal, the contents of this warrant or the fact that it was issued.

Special Master: This search shall be conducted by a Special Master pursuant to Penal Code §§ 1524(c)-(g). The Special Master shall be _____.

Search Conducted By Expert: The search shall be conducted by a person having expertise to identify the described evidence. The expert shall be: *[Insert name]*

Anticipatory Warrant: Having determined that probable cause for this search will result when the triggering event described in the supporting affidavit occurs; and, furthermore, that there is probable cause to believe that this triggering event will occur; it is ordered that this warrant shall be executed without undue delay upon the occurrence of the triggering event.

Covert Warrant: The evidence described in this warrant shall not be removed from the premises. An inventory of all evidence on the premises shall be prepared showing its location when discovered. Said evidence shall also be photographed or videotaped to show its location. Compliance with the receipt requirement of Penal Code § 1535 is excused until *[insert date]* unless an extension is granted by this court. Within two days after this warrant is executed, the following shall be filed with this court: (1) the inventory, and (2) the original or copy of all photographs and/or videotapes.

Off-Site Computer Search Authorization: The computers and computer-related equipment that may be searched pursuant to this warrant shall be removed from the premises and searched at a secure location.

Time Extension (Financial Records): The officers, employees, and agents of the financial institution served with this warrant need not produce the records within ten days of service as required by Government Code § 7475. Instead, the records shall be produced on or before *[insert date]*.

Disposition of Property: Pursuant to Penal Code §§ 1528(a), 1536. all property seized pursuant to this search warrant shall be retained in the affiant's custody pending further court order.
